

ARTICLE TEMPLATE & SPECIFICATIONS

The following template has been updated for the 2017 CCBST Conference in Vancouver and follows previous CCBST formatting.

ALL ARTICLES SHALL CONFORM TO THE FOLLOWING SPECIFICATIONS:

Length: Papers shall preferably be between 10 and 15 pages in length including appendices.

Page Format: 8.5" x 11"

Margins: 1" on all 4 sides (resulting text space: 6.5" x 9")

Typography: Text: Times New Roman 11pts justified
Line Spacing: 1.15

Titles:

- **Article Title:** Times New Roman, bold 14pts all caps, alignment centre
- **Primary section titles:** Times New Roman, bold 11pts all caps, align left, skip three lines from Paper Title or preceding section, skip two lines between section title or body text
- **Subtitle (secondary sections):** Times New Roman, bold 11pts lower case, alignment left side, skip two lines before Subtitle, one line after
- **Figures and Tables Title:** Times New Roman, 9pts lower case, align left side, skip one line after Subtitle or Body text preceding

Point Form: First point ¼" from left side margin. Text at ¼" of the point. All additional sub points are at ¼" from preceding point to a maximum of 3 levels.

Example:

- 1) Duis aute irure dolor
 - a) Lorem ipsum doloures
 - b) Quesni dolores
 - i) Excepteur sint occaecat cupidatat non proident
 - ii) Sint occaecat cupidatat non proident

Tables, Photos and Figures: All captions shall be below photos and figures.
All captions shall be above tables.

Photo Image Quality: Minimum 300dpi recommended, embedded into WORD document.

References: References shall follow the format required by the Canadian Journal of Civil Engineering. Each citation within the text shall be by (author, date) or by author (date). If there are more than two authors, then only the first author followed by 'et al.' can be provided. A reference list at the end of the document should include the author(s) names(s), the title of the paper of article cited together with the publication source including the date and where appropriate the page number. Where material has been gathered from the Internet, then providing URLs plus the date accessed is required.

Abstract: Abstract should contain no more than 300 words

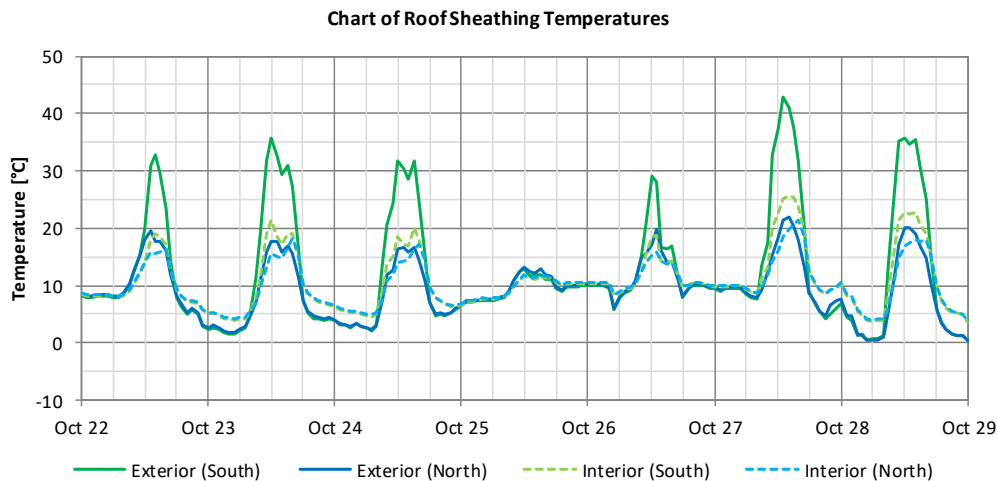


Figure 1: Sed ut perspiciatis unde omnis iste natus error sit voluptatem accusantium doloremque laudantium
